This newsletter provides updates on recent alcohol research and policy relevant to Ireland and Northern Ireland.

In the May edition you will find a number of data and research publications, including a recent report on the costs and benefits of the Sale of Alcohol Bill as well as a WHO report on zero and low alcohol drinks. This edition also features plans by the Irish government to introduce health labels for alcohol products and a House of Commons briefing paper on the new alcohol duty system coming into effect in the UK. A new 'innovation of the month' features the Leeds City Council Alcohol Licensing Matrix. The newsletter also includes details of a new all-island Foetal Alcohol Spectrum Disorder Hub and the PEACEPLUS Funding Programme.

Policy and Legislation

Ireland to introduce comprehensive health labelling of alcohol products

Ireland has signed into law the Public Health (Alcohol) (Labelling) Regulations 2023, which will see comprehensive health labelling of alcohol products sold in Ireland from 2026 and provide that similar health information will be available for customers in licensed premises. The law will apply from 22 May 2026 and there is a three-year lead-in time to give businesses time to prepare for the change.

The new alcohol duty system



The UK Government will implement a new alcohol duty system from 1 August 2023. This briefing discusses the current and new duty regime, and how the new system has been developed. The incoming system simplifies the current structure, and broadly taxes alcoholic products more the stronger they get. Provisions under the Windsor Framework will apply the new alcohol duty system in Northern Ireland.

Data and Research

The Sale of Alcohol Bill (2022): An analysis of costs and benefits



This report by Prof Thomas Babor (University of Connecticut) notes that many provisions in the Sale of Alcohol Bill have the potential to increase alcohol availability and facilitate access to drinking opportunities. Based on alcohol availability theory and the considerable amount of supporting research, it is highly likely that the Bill could contribute to an upward trend in alcohol consumption and alcohol-related harm. The report concludes that the costs of expanding the night-time economy are likely to far outweigh the benefits if public health issues continue to be ignored.

A public health perspective on zero and low-alcohol beverages

According to the WHO, significant uncertainty remains about the effects of zero and low-alcohol beverages (NoLos) on alcohol consumption at the population level and their effects on public health. Relatively little is known about the effectiveness of policy-levers to address the availability of NoLo products. The WHO recommends that additional research, independent from the alcohol industry, is needed to determine viable policy solutions to NoLo products.

Alcohol control policies reduce all-cause mortality in Baltic Countries and Poland between 2001 and 2020



The aim of this study was to evaluate the impact of alcohol control policies in the Baltic countries and Poland, which were implemented between 2001 and 2020, on all-cause mortality. The authors concluded that there was a reduction in all-cause mortality among men 20+ years of age in Baltic countries and Poland, and thus, the policies should be continued.

Innovation of the month

Leeds City Council Alcohol Licensing Data Matrix

Within Leeds, there are some areas which have high levels of deprivation, as well as high levels of alcohol related harm and alcohol related antisocial behaviour. Leeds City Council licensing and public health teams worked together to develop an alcohol licensing data matrix. This matrix demonstrates where a locality is at risk of health harms from licensing activity by ranking localities against each other through comparing different data sets.
