#### **New website highlights Belfast health inequalities**

A Health Inequalities conference held in Farset International highlighted the shocking health inequalities experienced by the local population of Belfast. Opening the conference Northern Ireland Health Minister, Michael McGimpsey, demonstrated his strong support for the conference, and highlighted the need to champion public health and tackle serious problems such as poverty, inequality and social exclusion by coordinated action right across government. ### **Fuel poverty and health – 2009 update**

Fuel poverty remains a huge concern in both Northern Ireland and the Republic of Ireland with growing numbers of people at risk of being unable to heat their homes. Recession is placing more people at risk of fuel poverty across the island, as unemployment and dependency on welfare rises. IPH published its Annual Update on Fuel Poverty and Health, on 2 December highlighting developments across Ireland in policy and research. The most recent figure for fuel poverty in the Republic of Ireland shows a rate approaching 10 per cent of households in 2007, with lone caregivers with children most likely to experience fuel poverty. In Northern Ireland the number of people dying as a result of cold has increased steadily since 2003, with excess winter deaths now approaching 1,000 per year.

IPH will continue to contribute to the development of interventions to tackle fuel poverty and protect the health and social wellbeing of fuel-poor households in 2010.



### **6<sup>th</sup> Population Health Autumn School – Podcasts available**

Better understanding of complex public health interventions was the focus of the 6<sup>th</sup> Population Health Autumn School. Over 150 delegates from Ireland, United Kingdom, Sweden and the Netherlands gained a greater understanding of complex interventions and the need to develop theory, evidence and knowledge translation.

Speaking at the event, Chief Medical Officer for Northern Ireland, Dr Michael McBride, welcomed the conference theme of building stronger links between policy and practice and congratulated the Centre of Excellence for Public Health (NI) on its work looking outwards across borders, highlighting the school as a prime example of good North South cooperation.

### **IPH welcomes action from Northern Ireland Assembly Health Committee on obesity**

Obesity continues to create headlines as a major public health issue across Ireland. IPH welcomed the report from the Northern Ireland Assembly Health Committee stressing the need for all sectors to help in halting this epidemic. The Committee's wide-ranging and comprehensive report followed its recent inquiry which focused on current evidence and new possibilities for obesity prevention.

IPH evidence stressed the need for a broad cross government approach and identified the importance of urgent and short term action particularly for those who are more vulnerable to obesity, and the necessity for action to improve the physical environment and promote active transport.

### **DETERMINE update**

DETERMINE is a three year EU-funded project aiming to achieve greater awareness and capacity amongst decision-makers in policy sectors to take health and health equity into consideration. IPH is leading one of the work packages which aims to strengthen knowledge on policies and actions addressing the social determinants of health inequalities. This includes identifying examples of economic evaluations that have been conducted on relevant policies and actions as well as exploring economic arguments that are or could be used. ### **Analytical approaches to small area data gaps**

The lack of accurate and reliable population data – particularly relating to lifestyles – to support public health action at small area level was the focus of a recent IPH seminar. The final 2009 Health Analysts' Special Interest Group (HASIG) focused on greater understanding of different analytical approaches that can be used to fill small area data gaps. Speakers included Dr Diane Anderson, Public Health Agency (Northern Ireland), Professor Anthony Staines, Dublin City University and Dr Julian Flowers, Eastern Region Public Health Observatory. ### **Injury Prevention Conference highlighted good practice**

### **Public Health Alliance for the island of Ireland (PHAI) Roadshows**

Recent PHAI roadshows took place in Belfast, Derry, Dublin and Cork and highlighted an interest in increasing membership. ## **Consultations**

### **Department of Enterprise, Trade and Investment (DETI) Draft Strategic Energy Framework 2009**

The Draft Strategic Energy Framework 2009 published for consultation by DETI sets out proposed priorities for Northern Ireland's energy future over the next 10 years. IPH welcomed actions to address fuel poverty and highlighted the need for stronger commitment to low-income and vulnerable households. The drive towards renewable energy to address climate change is particularly important as it has major health benefits. A focus on renewable energy can help address climate change which has been identified as a major health issue of the 21<sup>st</sup> Century.

### **Department for Regional Development (DRD) Regional Transportation Strategy Review**

DRD launched a review into the current Regional Transportation Strategy in September 2009. Travel behaviour can make a significant contribution to physical activity levels and subsequent risk of poor health including conditions such as obesity. DRD can play a key role in tackling obesity in Northern Ireland through the Regional Transportation Strategy. IPH recommended that improving health and well being should be at the core of the new Strategy.
