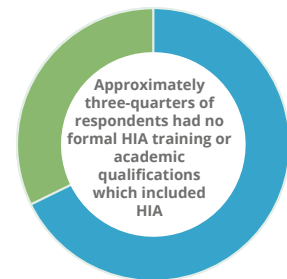
The new HIA leadership team met eight times in 2023 to coordinate the delivery of HIA work in line with our annual IPH Business Plan.

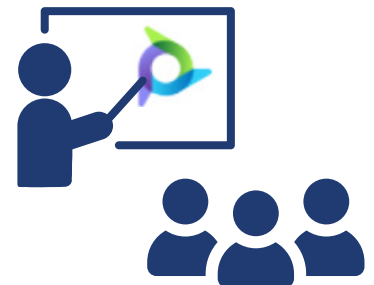

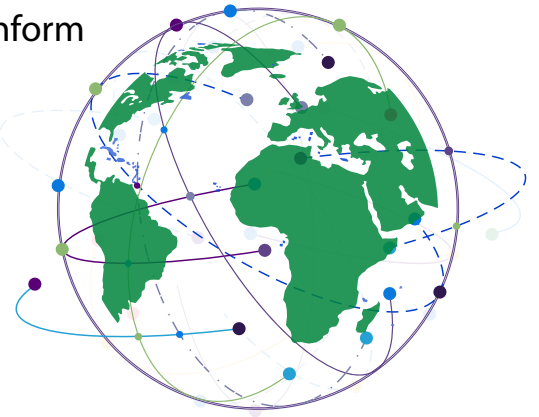
Working with partners in the UK, Europe and globally to develop HIA

We contributed to a HIA expert consultation to inform the strategic direction of HIA in World Health Organization Europe.

We supported a UK Health Foundation funded report [Health Impact Assessment - Current use and future opportunities to improve health and reduce health inequalities](#). An Evidence Brief was also published entitled [Sick Britain: A call for mandatory Health Impact Assessments across government with the support of a dedicated 'Health in All Policies' support unit](#).

We worked with colleagues across the UK to represent Northern Ireland in the UK-wide NIHR funded study [Developing Methods for System-Informed Health Impact Assessment](#).

We shaped UK policy development as active members of the Institute of Environmental Management and Assessment (IEMA) Health Working Group. The group developed a response to the UK consultation on Environmental Outcomes Report.
